



attractive rate, also benefited from a weaker SEK. Funds with more credit risk also posted strength when the risk tolerance returned to the market. Bond funds with longer average duration were negatively affected by rising market rates. Our assessment is that the central banks have reached the end of their rate hikes and that the phase of rate cuts will begin in the middle of 2024.

Our holdings have a neutral average duration in the fixed income portfolios as we believe that the cycle of rate hikes has reached its peak. The fund also has an overweight in corporate credits. We are retaining a long-term strategic position in emerging market bonds as well as in funds with focus on sustainable bonds and credits.
