The aim of the index is to reflect the performance of small caps worldwide in the global equity markets, excluding those companies that do not meet the sustainability requirements of the index. 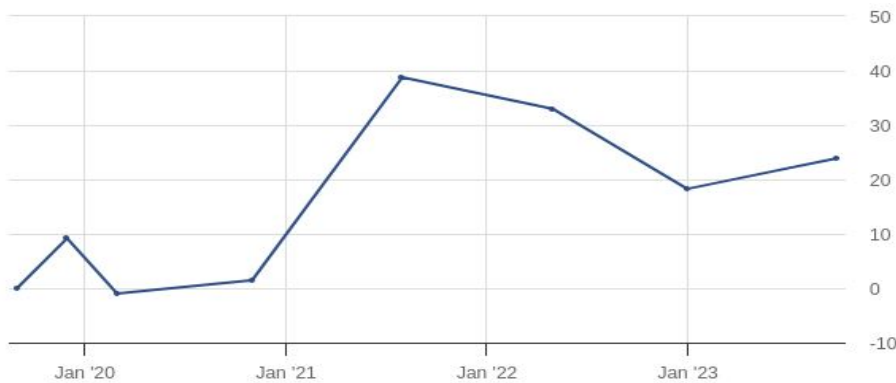

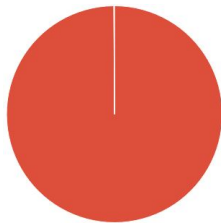
