

# Handelsbanken Pension 40 (A1 SEK)

The fund is primarily intended for investors born in the 1940s. The fund is suitable for pension savings, which means that as you age, the fund investments become safer by gradually switching investments from the equity market to the fixed income market. The fund is reported as an Article 8 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).

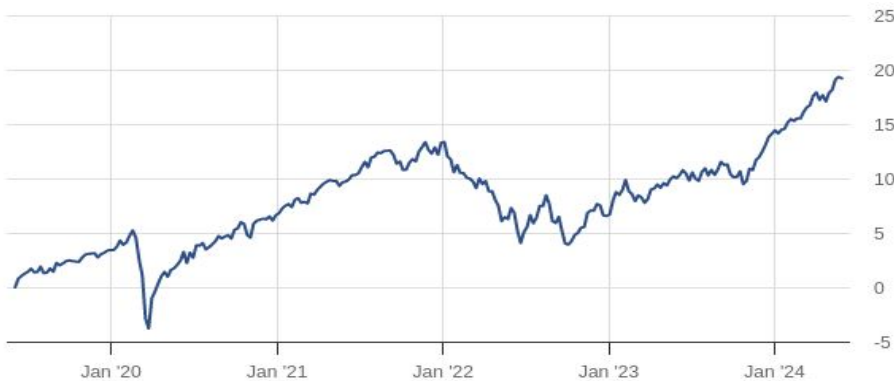

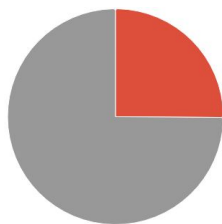
