The fund is primarily intended for investors born in the 1940s. 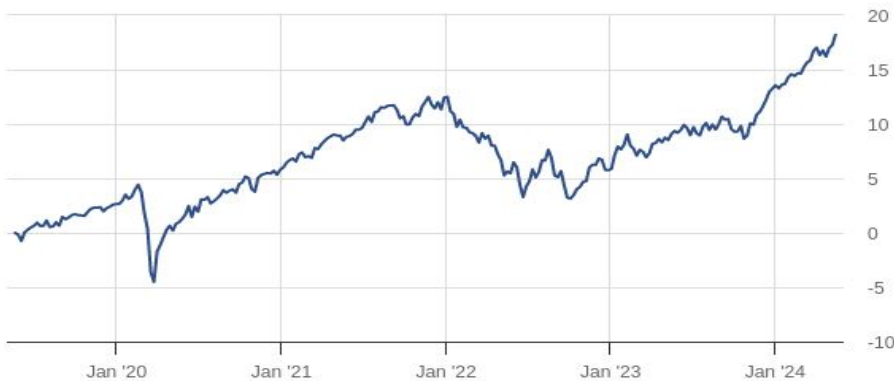

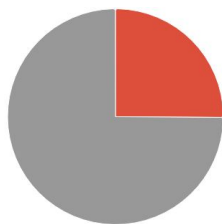
