

# Handelsbanken Kreditt (A1 NOK)

The fund is an actively-managed credit fund that invests in interest-bearing securities issued on the European credit market as well as a maximum of 15% in other interest-bearing securities issued in a European currency. The fund shall have a modified duration between 0 and 3 years. The credit duration is limited to 5 years. Fund assets may be invested in interest-bearing financial instruments with a minimum rating of BB- from S&P or a corresponding rating of Ba3 from Moody's. A maximum of 5% of the fund's value may have exposure to currency risk in a currency other than NOK. The fund is reported as an Article 8 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).

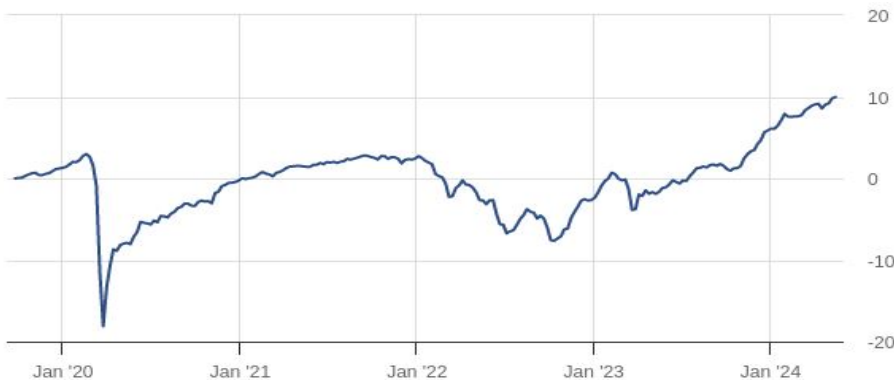

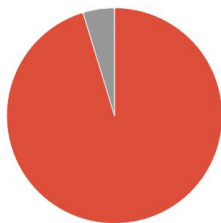
