

# Handelsbanken Kreditt (A10 NOK)

The fund invests in interest-bearing financial instruments with a minimum rating of BB- from Standard & Poor's or Nordic Credit Rating or an equivalent rating of Ba3 from Moody's. A maximum of 5% of the fund's value may have exposure to a currency risk in a currency other than NOK. The fund is reported as an Article 8 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).

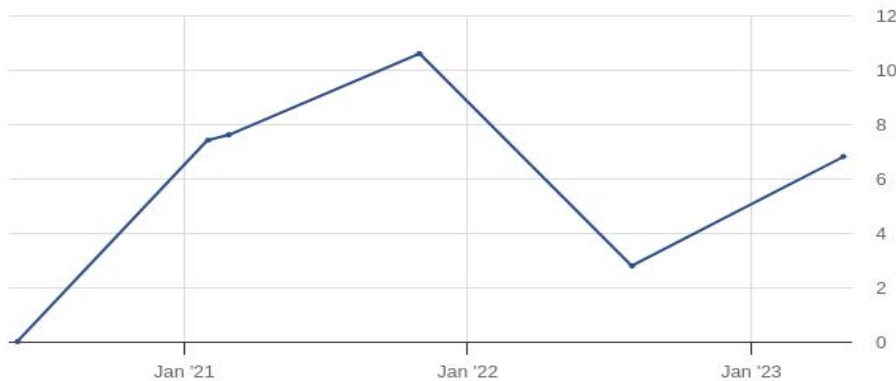
