The fund invests in interest-bearing financial instruments with a minimum rating of BB- from Standard & Poor's or Nordic Credit Rating or an equivalent rating of Ba3 from Moody's. A maximum of 5% of the fund's value may have exposure to a currency risk in a currency other than NOK. 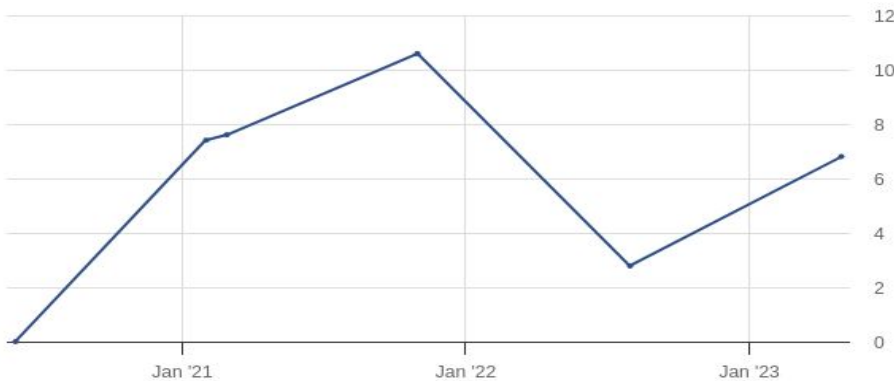
