The investment focus is global and thus not limited to any specific sector or region. 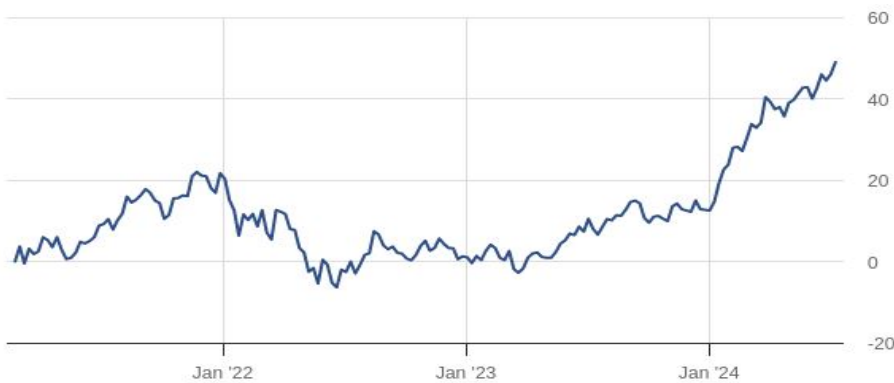
