

# Handelsbanken Auto 100 Criteria (B1 SEK)

The fund is a rules-based fund of funds and invests 100% in the equity market, with 50% in the Nordics and the remainder in the rest of the world. The fund invests a minimum of 90% of its assets in mutual funds within Handelsbanken. The fund is reported as an Article 8 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).

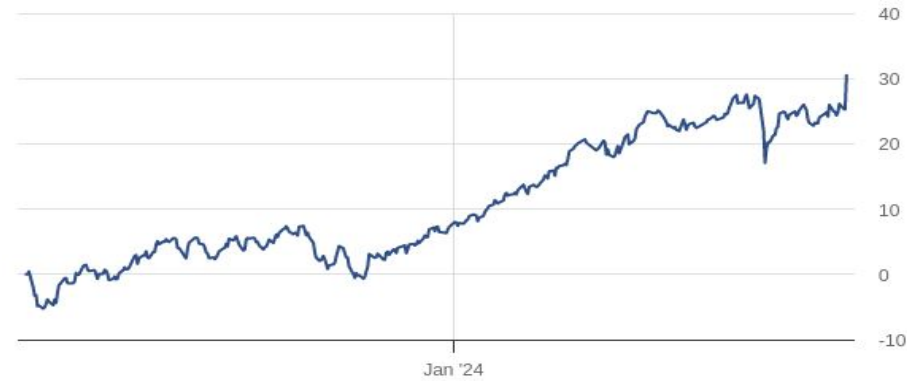
