The fund is an index fund that tracks the Solactive ISS ESG Screened Paris Aligned Emerging Markets Index with the aim of reflecting the performance of companies in the emerging markets, while excluding those companies that do not fulfill the sustainability requirements of the index. Given that investments are made in foreign equities denominated in currencies other than the fund's base currency, fund investments are associated with currency risk. The fund is reported as an Article 9 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).

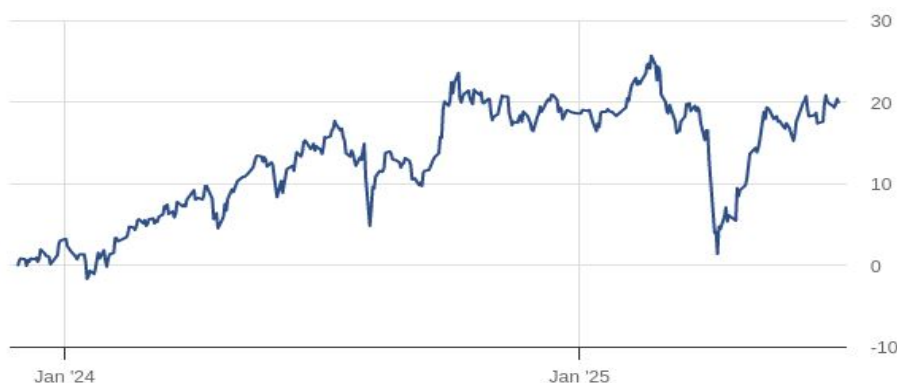
