The fund is a rules-based fund of funds and invests 100% in the equity market, with 50% in the Nordics and the remainder in the rest of the world. The fund invests a minimum of 90% of its assets in mutual funds within Handelsbanken. For this fund, the fund company's Enhanced exclusion level applies. 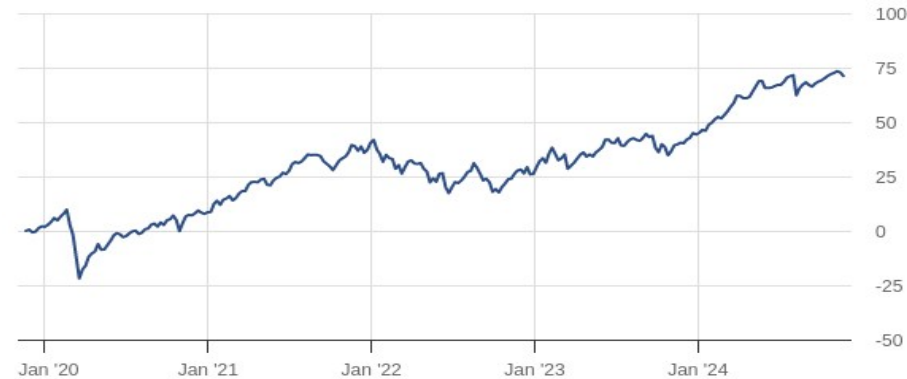
