The fund is a rules-based mixed fund and invests 25% in the equity market and the remainder in the fixed income market. The fund invests a minimum of 90% of its assets in mutual funds within Handelsbanken. For this fund, the fund company's Enhanced exclusion level applies. 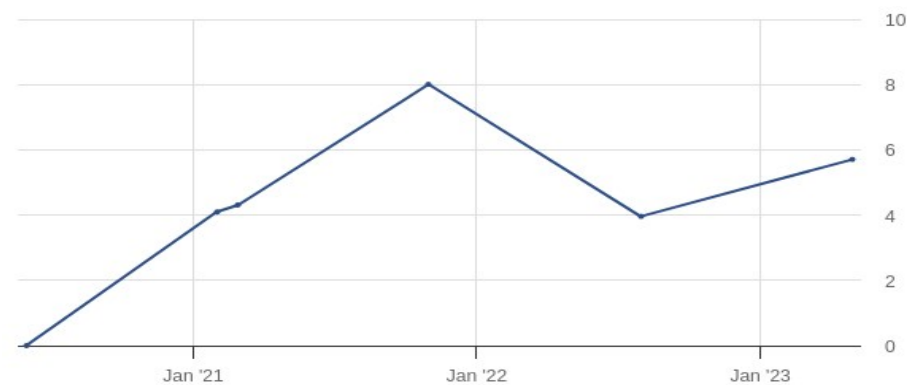
