The fund is actively managed and invests in funds, equities and other financial instruments with exposure to equities, fixed income and alternative investments. The proportion of equities varies between 45-70%, the fixed income proportion fluctuates between 10-60% and alternative investments range between 0-25%. This fund targets customers of Handelsbanken Private Banking with the Premium agreement that explicitly permit investments in the fund. The fund is reported as an Article 8 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).

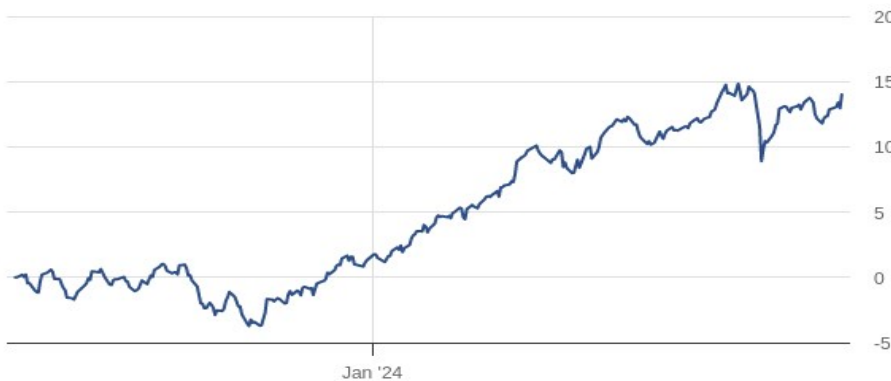
