This index includes all of the companies registered in the Stockholm stock exchange, excluding those companies that do not meet the sustainability requirements. The fund is reported as an Article 8 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).

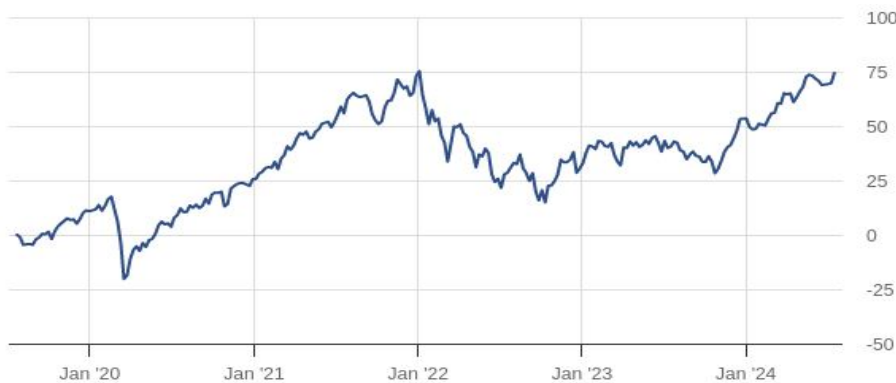
