The fund is an exchange-traded index fund and its objective is to follow the performance of the Solactive ISS ESG Screened Nordic 50 Index as closely as possible. The index consists of a selection of about 50 of the most-traded companies on the Nordic stock exchanges that meet the sustainability requirements of the index. The fund is reported as an Article 8 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).

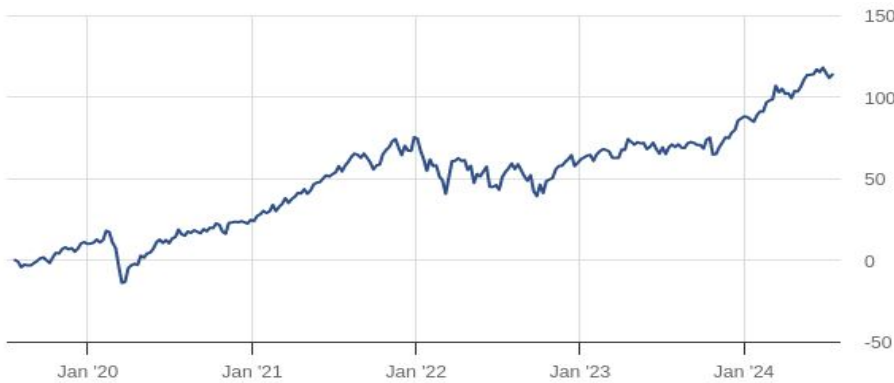
