

# Handelsbanken Amerika Småbolag Tema (A10 NOK)

The fund is actively managed and invests in equities that are primarily issued by small companies in the U. S. , as well as in Canada and Mexico. As a result, the fund has a currency exposure to these markets. The thematic investment strategy provides for investments that occur in a limited area in which development is deemed to result in a structural change to the economy and society. This change provides favorable conditions for companies active within the area to create profitable growth over time. The fund is reported as an Article 8 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).



## Portfolio manager comments — Q2 2024

US small caps posted a slightly weaker performance during Q2. The downturn was driven primarily by companies within cyclical sectors due to signs of a weaker US economy. However, several companies within the technology sector continued to post strength, particularly companies with exposure to electrification and generative AI. Although there are signals that inflation in the US is beginning to fall, the US central bank wants additional clear signs before they begin a phase of cuts to the key rate. Fund returns benefited primarily from the strong performance in Tyler Technologies, Napco Securities and Clean Harbors. At the sector level, the technology sector was the

Fund returns were negatively affected by a number of cyclical holdings such as SiteOne Landscape Supply, Pool Corp, WillScott Mobile Mini and Brunswick.

A number of new companies were added during the quarter and included the packaging company Aptar Group, the electricity distributor Wesco International as well as Itron, which provides technology, services and solutions for the electricity and water markets. The software company Nutanix and the fashion company Ralph Lauren were sold. The fund continues to hold high-quality companies with exposure to structurally strong themes such as re-shoring, electrification and digitalization.
