The fund is an index fund with the objective to follow the performance of the Solactive ISS ESG Screened Sweden 100 Tradable Index Index as closely as possible. The index aims to reflect the largest and most-traded equities on the Nasdaq OMX Stockholm Exchange (Stockholm stock exchange), excluding those companies that do not meet the sustainability requirements of the index. The fund is reported as an Article 8 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).

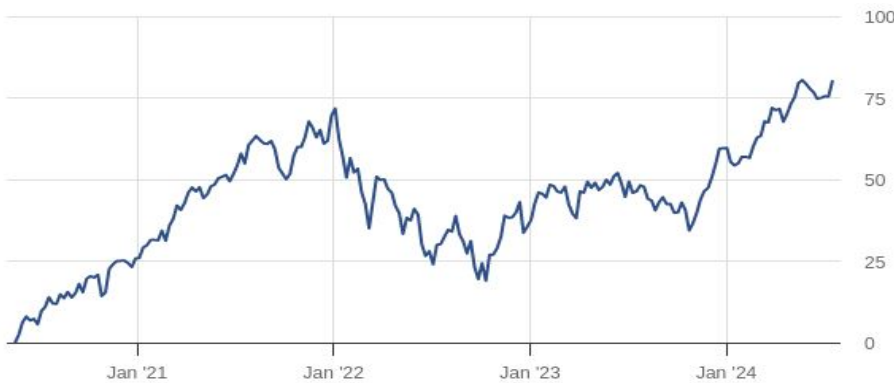
