

# Handelsbanken Auto 25 Criteria (B1 SEK)

The fund is a rules-based mixed fund and invests 25% in the equity market and the remainder in the fixed income market. The fund invests a minimum of 90% of its assets in mutual funds within Handelsbanken. The fund is reported as an Article 8 fund pursuant to EU regulation 2019/2088 on sustainability-related disclosures in the financial services sector (SFDR).

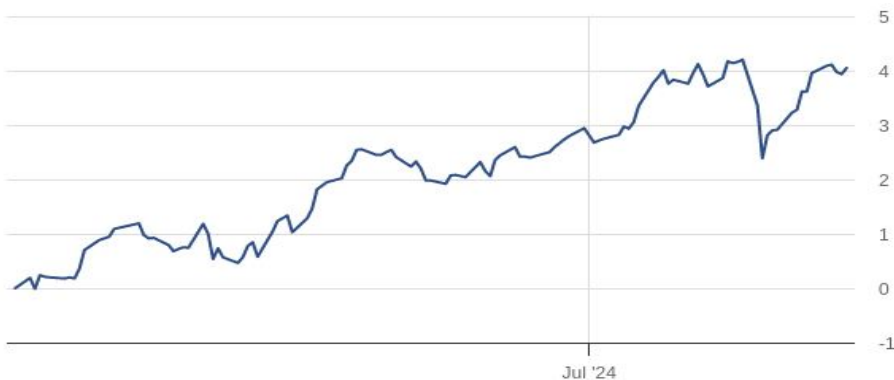
